G-Invoicing (GINV) Readiness for FY24

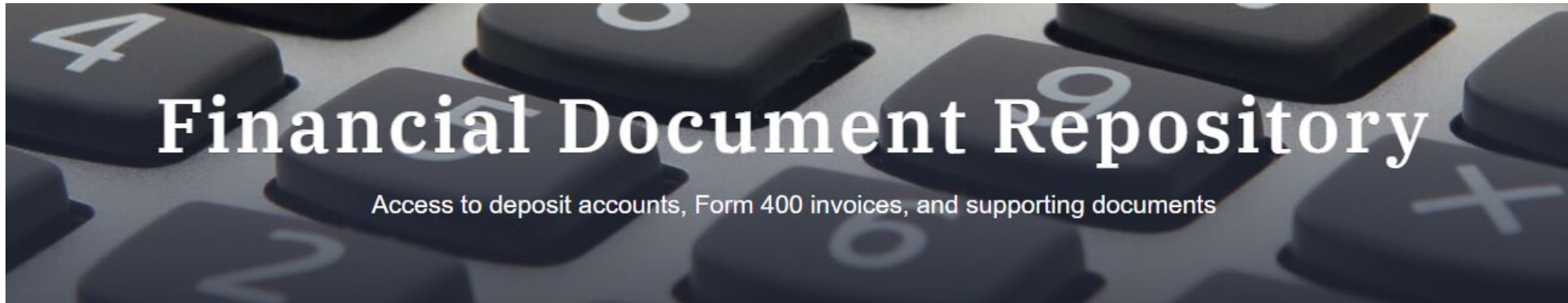
- GPO has begun working with our initial pilot agencies on General Terms and Conditions (GT&Cs) and Advanced Orders. We anticipate expanded support for all other GPO customers in early calendar year 2024.
- GPO is in the process of developing our 7600EZ solution for GPO Print/Publishing Services. Release date to be determined.
- As Fiscal Service moves towards retiring IPAC processes, all legacy IPAC billings must be complete by September 30, 2025, or will be considered In-Flight Orders.

- Allows customers to use their current Deposit Account Billing Address Code (BAC) to establish a G-Invoicing Deposit Account
- Single sign-on using GPO's Identity Management Service (GIMS)
