1. Bid opening date remains October 3, 2024.
2. On Page 1 & 2 of 7, change the total dollar amount to \$259,252.06 from \$185,178.06 which is an increase of \$74,074.00.
3. On page 4 change Clear plastic acetate vinyl or polypropylene plastic stock from (0.010" to 0.040")
4. On page 3 add to Description: Cut outs are intricate and fine in detail, must have clean edges.
5. Replace Page 7 with the updated page 7.

All other specifications remain the same.
